# **Key Discussions from Forum Meeting**

## Skye and Lochalsh Sub-group Workshop held on the 18th July

J Ford provided an overview of the Skye and Lochalsh Sub-group Workshop held on the 18th July. A key issue identified at the workshop was the lack of knowledge about existing services and support. To improve this:

- Workshop members took part in a mapping exercise which identified more services, toolkits, and support to be included in the SLWR Drug and Alcohol Forum Directory of Resources and Services
- Participants agreed the Forum should submit an expression of interest to the Highland Alcohol and Drugs Partnership Local Improvement Fund for a project that facilitates the sharing of information, engages with key groups and supports capacity building of local groups to develop drug and alcohol services.

A review of the workshop will be in the September Bulletin.

## Lochalsh Community Champions Project

J Ford gave an overview of the Lochalsh Community Champions Project to be submitted to the Highland Alcohol and Drugs Partnership Local Improvement Fund. N Kelly (Broadford Youth Club) had raised a concern about this project which he wanted the rest of the forum to discuss. His primary issue with the project is it is not Skye based and does not support a dedicated Drug and Alcohol worker for the area. There was some discussion by meeting participants about the project including:

- Aversion to the terminology 'Community Champion'. J Ford explained the term champion has been used as the Scottish Government use this in relation to health champions however agreed that when developing the network there should be consultation about the name.
- Concerns about protecting personal information and confidentiality. J Ford advised that KLCT has strong safeguarding and GDPR polices which will be followed in the project

- Location of project and lead organisation. J Ford explained that Kyle and Lochalsh Community Trust are leading the EOI as they have the governance structure and established community network through their community transport e-bus, the Lochalsh Collaboration Forum and Lochalsh Loves Local project. In addition the Kyle of Lochalsh Youth Trust have a current drug and alcohol prevention programme and Living Hope the recovery charity are based in Kyle.
- Meeting participants acknowledged there is a need in Skye however the Local Improvement Fund was not the correct fund for a dedicated post and more evidence of need is required before a group is able to apply for funding for this.

There was agreement for Kyle of Lochalsh Community Trust and SLCVO to continue with the EOI because if the application is successful, it will develop a framework that can be shared across the area and would give the forum a dedicated resource 1.5 days a month which can support groups in gathering the evidence required to develop activities to support identified need.

### Samaritans Scotland

Fiona Thompson, Samaritans Scotland West Highland and Skye Project and Partnerships Manager gave an overview of their lone worker project and training they can provide Forum members, including their 'Conversations with Vulnerable People' course which is online running over two mornings – usually 09.30-12.30pm.
