- The purposes in the Terms of Reference were updated to include 'Facilitate training' and the document was signed-off by participants
- The group identified a number of areas where they feel the Forum could work together:
 - Engagement with young people (prevention, early intervention, child protection, education, youth groups)
 - Support for parents/families (family leaning)
 - Support for adults, particularly around alcohol there has been an increase in harm from alcohol since Covid-19 pandemic, issues are more complex and alcohol deaths is increasing
 - Engagement with employers especially in hospitality where there seems to be a culture of alcohol (finish shift and go for a drink). For lots of young people hospitality is the first job and they get exposed to this culture. Forum to work with employers so they understand this issues around drugs and alcohol and how to support their employees
 - o Identify where people with alcohol & drug issues can get support particularly when in crisis and post-crisis support when people return home
 - Developing incident support networks being able to tap into collective knowledge
 - Raising the profile of issues around under age vaping
 - Collaborative working to get the best support for the area
- The group identified other organisations /services that should be invited to the forum including representation from:
 - o GP Clusters
 - o NHS Highland Rural Support Team
 - Hospitals
 - Pharmacists
 - School nurse
 - School counselling services
 - o Adult counselling services
