Background of the Skye and Lochalsh Drug and Alcohol Forum

Operating for over 12 years the Skye & Lochalsh Drug and Alcohol Forum provided an important network for those dealing with substance misuse issues in the Skye and Lochalsh area.

The forum had representation from a variety of agencies, including health, police, education, social work, the third sector and community members. It was part of the Highland Drug and Alcohol Partnership (HADP), a multi-agency strategic partnership responsible for setting the overarching alcohol and drugs action plan and strategy for Highland. The Forum stopped meeting in 2020 due to the Covid Pandemic and now is looking to start -up again.

On the 14th of November 2022 at a meeting with Ward 10 Councillors & Ward Manager, Highlife Highland Youth Development Officer, Portree High School Head Teacher, Police Scotland and third sector representatives, it was agree to re-start the Forum. These notes are to support the planning meeting for the Forum which is being expanded to include Wester Ross.



SLWR Drug and Alcohol Forum Terms of Reference

Draft Skye, Lochalsh and Wester Ross Drug and Alcohol Forum Terms of Reference Purpose and objectives

To achieve improved outcomes for individuals, families and communities by preventing and reducing drug and alcohol related harm by:

- Sharing knowledge, data and information to better understand the local needs relating to drug and alcohol prevention, recovery and the demand on local services.
- Sharing Information regarding local, regional and national activity including training, service provision and events
- Highlighting good practice and learning from the Forum to a wider audience.

Membership will consist of representation from third sector groups, the public and private sector and community members who want to support the objectives of the Forum, including:

Working Methods

- The forum will adopt a shared learning approach.
- Forum meetings will be held online every two months.
- The position of Forum Chair and administration support will be reviewed annually.
 - March 2023 to March 2024
 - The position of Chair will be held by Jo Ford, Chief Officer of Skye and Lochalsh Council for Voluntary Organisations
 - Administration support will be provided by SLCVO
- Forum members may wish to invite individuals to contribute to agenda items.
- Forum Chair will act as a communication channel between the Highland Alcohol and Drug Partnership and Forum
- There may be occasion to convene sub-groups to progress particular work-streams. Sub-group meeting will be held as required.

Forum Member Roles and Responsibilities

- Regularly attend forum meetings where this is not possible to send appropriate representation
- Ensure the views of their area of work are adequately represented in forum discussions and agreements
- Assist in the development, agreement, and implementation of actions through the subgroup model to address the priorities of the Forum.
- Act as a communication channel between their organisation and the Forum.
- Take part in time limited sub-groups to take forward the Forum's agenda, proposing and delivering actions in a timely manner.
- Share good practice within and across the Forum.
- All Forum members must respect the right of each Forum member to be able to freely
 express, within the obligations of mutual courtesy and respect, their views and concerns
 during discussion at Network meetings.



Priorities for April 2023 to March 2024

As this is a new start to the Forum it is proposed this year we focus on two priorities:

- 1. Establishing information sharing and communication pathways, for example:
 - a. Use Forum meetings to provide regular updates from members (email template sent to groups two weeks before meeting to provide an update that can be collated into an information document)
 - b. Share training opportunities via a regular emails or existing newsletters such as SLCVO's third sector bulletin
 - c. Encourage groups to list actives/services with ALISS and local directories
 - d. Promote where the general public can find information and support
- 2. Closing the S&L Drug and Alcohol Forum legacy bank account and using the funds. The old drug and alcohol forum has a bank account which has around £5,000 in cash, there is one current signatory on this account, however, to access funds we need two. As the forum does not deliver services direct it is proposed a sub-group is set-up to look at options as to how the funds could be used. Suggestions so far have been to run a series of blue Light Discos, use the funds for training or invite groups to bid for funding. This sub-group would work with the Chair and current signatory to distribute funds and close the account by the end of March 2024
